**Nonsidering Serving CSR As** A District Director? The Elections For District A, B, & C are Soon!

CSR is looking for activists who wish to run for one of three seats up for election on the California State Retirees Board of Directors. The CSR Board of Directors is the governing body of California State Retirees and usually meets three times per year at locations throughout the state. Board member duties include attending Board meetings, helping to coordinate chapter activities, helping chapter presidents and

members understand the issues affecting member welfare, participating in political action and providing overall leadership. The terms for Board members in Districts A, B, and C will conclude at the first CSR Board of Directors meeting in 2026. An election in each of the districts will be conducted only if more than one eligible candidate has consented to serve by the November 17, 2025, filing date. Candidates may also submit a brief 200-word statement regarding their qualifications. The election coordinator reserves the right to disallow any statement

material that is considered inaccurate. Ballots in the contested race(s) will be sent to the electorate December 1, 2025, and are due at CSR Headquarters by January 2, 2026. District directors are elected by chapter members within their respective districts.

To be eligible to run, you must be a member in good standing. Candidates must also reside within the district holding the election and in a chapter assigned to the district. Sharon Stoltzman holds the district director position for District A, representing Chapters 4, 9, and

20. Leticia Soria holds the district director position for District B, representing Chapters 10, 26, 31, and 36. Maria Aguilar holds the district director position for District C, representing Chapters 1, 3, 21, and 23.

### Savvy Senior: How to Get Help with Your Medicare Costs

Dear Savvy Senior,

Does Medicare offer any financial assistance for struggling seniors? My mom lives primarily on her Social Security survivor benefit and is having a hard time paying her Medicare costs.

Need Assistance

Dear Need,

There are actually several different financial assistance programs that can help Medicare

beneficiaries who are having a difficult time paying their out-of-pocket health care costs. Here's what's available, along with the eligibility requirements and how to apply.

#### **Medicare Savings Programs**

Let's start with a program that helps pay premiums and out-of-pocket costs for Medicare Parts A and B. It's called the "Medicare Savings Program," and it has several different benefit levels for people based on their income and asset level. At its most generous the program will pay your Part A and B premiums and pretty much all your Medicare deductibles, coinsurance and copayments. At its least generous the program will pay just your Part B premium.

To qualify for a Medicare Savings Program, the minimum standard set by Medicare is an income under 135 percent of the federal poverty level, which at the moment works out to around \$1,715 a month for individuals (or \$2,320 for married couples). Everything counts towards income, including payouts from 401(k) plans, pensions, Social Security, and help from family members. Medicare also allows states to impose an asset test, which can be as little as \$9,430 per individual (\$14,130 for married couples), not counting your house, car or personal belongs, but

program she may be eligible for called "Extra Help." To get it, your mom will need to apply through her Social Security office. Depending on your mother's income level, this program will pay part or all of her Part D prescription drug plan's monthly premiums, annual deductibles and prescription co-payments. In



counting retirement savings and bank accounts.

But some states have made their Medicare Savings Programs a lot more generous, with much higher income limits and in some cases no asset tests at all. And the program may be called something else in your state. To find out if you qualify or to apply, contact your state Medicaid program. Visit Medicaid.gov or call all 800-633-4227 for contact information.

#### **Medication Assistance**

For help with Medicare (Part D) prescription drug plan costs, there is another completely separate low-income subsidy

2025, individuals with a yearly income below \$23,475 (\$31,725 for a married couple), and assets under \$17,600 (\$35,130 for a married couple) can qualify for Extra Help.

If she's eligible to be in a Medicare Savings Program, she will automatically qualify for Extra Help. But because the requirements are slightly different, even if she doesn't qualify for a Medicare Savings Program for Part B, she might be able to get Extra Help for Part D. #### **Other Programs**

Depending on your mom's income level, needs and location there are many other financial assistance programs that can help like Medicaid, SSI (Supplemental Security Income), PACE (Program of All-inclusive Care for the Elderly), SNAP (Supplemental Nutrition Assistance Program), (LIHEAP) Low Income Home Energy Assistance Program and many others.

To help you find out what types of assistance programs she may be eligible for, and learn how to apply for them, go to

BenefitsCheckUp.org. This is a free, confidential website designed for people age 55 and older that contains more than 2,500 programs.

#### **Retirees: Go Paperless with Your Tax Statements**

If you opt in to get electronic 1099-R or W-2 tax statements by December 31, CalPERS will notify you once your statement is ready to view online.

#### 5 Steps to an Easier Tax Time

Streamline how you get your statement in just five steps:

- 1. Log in to myCalPERS (if you need assistance, visit Using myCalPERS).
- 2. Choose a verification method

and enter your code when prompted.

- 3. From the My Account dropdown menu, choose Mailing Preferences.
- 4. Scroll down to Tax Statements and select the Online option.
- 5. Click Save.

That's it! CalPERS will notify you via email when your statements are ready in early January. By going paper-free, you'll skip the wait and the clutter.

If you don't choose to go electronic by December 31, you will still receive your tax statements in the mail. Please ensure your CalPERS account is updated to reflect the most current and valid address for accurate delivery.

Below are updates on 1) Delta Dental 2) CVS/Caremark, 3) Covid-19 Vaccine

#### **Delta Dental 2026**

In the September article, you read about the new dental enhancements, which will take effect January 1, 2026. The enhancements will allow "Delta Dental PPO, Basic, and Enhanced plan members to get routine services like exams, cleanings, and X-rays without those services counting toward the \$2,000 Calendar Year Maximum (CYM). Additionally, the dependent CYM will increase from \$1,500 to \$2,000. Subsequent to last month's article, I received communication from a retired member of the California State University (CSU) system who reported she had a CYM of \$1,500, not the \$2,000 CYM reported in the article. She went on to write the information in the article, "lead me to believe that the retirees of The CSU receive a lesser CYM than all the other State of California retirees" and she requested clarification.

At the risk of making the issue more confusing, I will try to clarify. While many CSU retirees enrolled in the Basic Plan do have a CYM of \$1,500, those who choose the Voluntary Enhanced Plan have a CYM of \$2,000. As with any dental, medical or vision plan, the devil is in the details. While many CSU retirees may only have a \$1,500 CYM, the CSU system pays 100 percent of the premiums for retirees enrolled

in the Basic Plan. Those CSU retirees who choose to enroll in the Voluntary Enhanced Plan have a \$2,000 CYM along with a \$15.70 monthly premium.

It should also be noted the CSU administers its own dental plan benefits for CSU retirees. CSU also negotiates with Delta Dental and other plans for those benefits and premiums, unlike most other State retirees who have their dental plans administered and negotiated through CalHR. I hope this clarifies the confusion related to why some retirees have a \$1,500 CYM and others have a \$2,000 CYM. #### CVS/Caremark 2026

Effective January 1, 2026, CVS Caremark (CVS) will replace OptumRx as the new pharmacy benefits manager (PBM) for the below listed CalPERS health plans and the CVS microsite, caremark. com/CalPERS, and phone lines are now active:

- Basic plan members can call CVS Customer Care: **833-291-3649**
- Medicare plan members can call SilverScript Customer Care: **833-291-3648**

The new contract will result in some formulary changes that may impact copays for some Basic and Medicare members or involve a change in medication to an equally safe and effective alternative. CalPERS reported, together with CVS, they will develop a range of options for our members to navigate any change and ensure medications are available when and where they are needed. For Basic and Medicare plan members impacted by the formulary change, CalPERS and CVS will have plans in place to minimize disruption, including a transition period for filling prescriptions no longer on the CVS formulary and an automatic

transfer of approved prior authorizations.

As a reminder, CVS/Caremark will be the new PBM in 2026 for those retirees in the following Basic Plans: Anthem Blue Cross Traditional, Anthem Blue Cross Select, Health Net Salud y Más, PERS Gold, PERS Platinum, Sharp Health Plan Performance Plus, UnitedHealthcare SignatureValue Alliance, UnitedHealthcare SignatureValue Harmony, and Western Health Advantage. Retirees enrolled in the following Medicare Plans will also be impacted and have CVS/ Caremark as their new PBM: Anthem Blue Cross Medicare Preferred, PERS Gold Medicare Supplement, and PERS Platinum Medicare Supplement. The following Basic Plans are not impacted by the PBM change: Blue Shield Access+ (HMO and EPO), Blue Shield Trio, Kaiser Permanente, and Kaiser Permanente Out-of-State. The following Medicare Plans will also not be impacted: Blue Shield Medicare, Kaiser Permanente Senior Advantage, Kaiser Permanente Senior Advantage Outof-State, Kaiser Permanente Senior Advantage Summit, Kaiser Permanente Senior Advantage Summit Out-of-State, Sharp Direct Advantage, and UnitedHealthcare Group Medicare Advantage. The new changes means CVS will manage retail, mail-order, and specialty pharmacy services, offering members an enhanced experience through a nationwide pharmacy network, digital tools, and improved customer service. Until January 1, 2026, members will continue to use OptumRx for all prescription services. For Medicare members, beginning January 1, 2026, SilverScript, an affiliate of CVS, will administer your pharmacy benefits.

#### **Covid-19 Vaccine**

During the September CalPERS Board meeting there was discussion about the Federal Government no longer covering the cost of the Covid-19 vaccine and not recommending the vaccine unless specific conditions are met. On August 27, 2025, the Food and Drug Administration (FDA) announced a change from its prior universal recommendation for the COVID vaccination, restricting the labeling to adults over 65 years of age and those adults and children over 6 months who are at high risk for severe COVID disease. CalPERS staff announced they would continue to cover vaccines for COVID-19, RSV, and the flu to support its members in making the best health care decisions for themselves and their families. Consequently, CalPERS and its health plans and PBM partners will continue to provide and cover the latest 2025-26 COVID-19 vaccine for any CalPERS members aged 6 months and older who choose it, without cost sharing and without the recent FDA limitations. The universal recommendation is unchanged from last year. This is also consistent with the approach recommended by the California Department of Public Health. Hopefully this information helps to ease the mind of those retirees wishing to get the latest COVID-19 vaccine. You can get your vaccines with your health care provider or through an in-network pharmacy in California. For the COVID-19 vaccination, pharmacies may ask for a self-attestation for a highrisk condition, or, if not at high risk, they may ask for a provider prescription. Please contact your health insurance plan if you encounter any difficulty in receiving the vaccine, or if you reside outside of California. #### **Turkey Sweet Potato Chili**

#### **Ingredients**

- 1 pound ground turkey
- 1 small onion, chopped
- 2 cups chicken broth
- 1 can (15 ounces) sweet potato puree or canned pumpkin
- 1 can (4 ounces) chopped green chiles
- 1 tablespoon chili powder
- 1 teaspoon garlic powder
- 1 teaspoon ground cumin
- 1 teaspoon curry powder
- 1/2 teaspoon dried oregano
- 1/2 teaspoon salt
- 1 can (15-1/2 ounces) great northern beans, rinsed and drained

Optional: Sour cream, fresh cilantro and sliced red onions

#### **Directions**

In a large skillet, cook turkey and onion over medium heat until turkey is no longer pink and onion is tender, 5-7 minutes, breaking up turkey into crumbles; drain. Transfer to a 3- or 4-qt. slow cooker.

Stir in broth, sweet potato puree, chiles and seasonings. Cook, covered, on low 4-5 hours. Stir in beans; cook until heated through, about 1 hour. If desired, top with sour cream, cilantro and red onions.

### **CSR Bill Watch**

The first year of the 2025-26 legislative session was extended for a day - with lawmakers working most of Saturday, September 13 – to take up and send to the Governor a complicated energy and environmental protection package that extends the state's emissions reducing cap-and-trade program for another 15 years (including providing \$1 billion annually to high speed rail), at the same time permitting additional oil drilling in our state. Such is how deals are made.

In total, the Legislature introduced over 2,800 bills this year. As this is written, 784 of those bills are awaiting action by the Governor. He has until October 12 to sign or veto all the bills that made it to his desk. In 2025, CSR supported 10 bills and monitored 54 others. Now, the focus turns to the November 4 special election, where California voters will have the opportunity to weigh in on Proposition 50. In response to the State of Texas undertaking a middecade redistricting gerrymandering of their 38 congressional districts to turn 5 of them from blue to red, Governor Newsom acted to do the exact same thing in California. Prop

50 would suspend California's independent redistricting commission and create entirely new maps for

California's 52 congressional districts that would, perhaps, turn five red seats to blue in 2026. Both sides have already started the advertising campaign barrage and, given what is at stake, you can expect to see Yes and No on Proposition 50 ads from now until election day.

Here is an update on the CSRsupported bills that survived this year, and their current status. We will report on the final results in the next edition:

#### **Support**

#### AB 280 (Aguiar-Curry)

Would create mechanisms and procedures to improve health plan provider directories to ensure that consumers receive accurate information and can get efficient access to care. STATUS: Two-year bill.

AB 371 (Haney) Would require that dental appointments be available within 48 hours, nonurgent dental appointments within 18 business days, and preventive dental care appointments within 20 business days of a request. STATUS: Twoyear bill.

**AB 1190 (Haney)** Would protect all consumers, but particularly seniors, from exploitative websites impersonating the DMV and overcharging for services.

STATUS: Two-year bill.

ACR 80 (Stefani) Acknowledges the month of June 2025 as Elder and Dependent Adult Abuse Awareness Month in California.

STATUS: Chaptered by the Secretary of State on June 25,

2025.

AJR 3 (Schiavo) Recognizes Social Security, Medicare, and Medicaid as the foundation for income and health care security for millions of Americans and calls on California's Congressional Representatives to repeal recently enacted legislation that threatens these programs. STATUS:

Chaptered by the Secretary of State on September 5, 2025. SB 23 (Valladares) Would exempt the primary residences of veterans who have received a 100% disability rating from the Department of Veterans Affairs from property taxes in the State of California. STATUS: Two-year bill.

**SB 56 (Seyarto)** Would exclude service-connected disability payments from the calculation of household income for the Low

Income Exclusion of the Disabled Veterans' Property Tax Exemption, as Veterans must receive that compensation in order to qualify for the tax exemption in the first place. STATUS: Two-year bill. SB 351 (Cabaldon) Would prohibit a private equity group or hedge fund involved with a physician or dental practice in California from interfering with the professional judgment of physicians or dentists. STATUS: Enrolled and presented to the Governor on September 23, **2025**. For a complete list of all bills that are being monitored by CSR, please see the most recent CSR Legislative Report online.

During Open Enrollment, you can enroll or make changes to your health, dental, vision, legal and supplemental life insurance plans. If there are no changes to be made, then no action is necessary. Your health, dental, vision, legal and supplemental life insurance plans will automatically continue into the next year. Visit our How to Enroll Retirees webpage for more information.

All changes made during Open Enrollment will be effective January 1, 2026.

#### **Retiree Health Benefits**


