## <u>To Your Health</u>

I had intended my August column to be my final column, but I extended my term as HBC Chair till September 30, 2023, so I'm giving an update on several HBC issues in this column.

1. Long Term Care Settlement Update

2. ACO REACH Update

#### 3. Dental Benefits Update Long Term Care Settlement Update

Elaine Edwards-Yahraus attended the last status conference held on July 28, 2023 and reports that the Judge approved the settlement pending any appeals. If you go to www.calpersltcclassaction. com.com you will see in the first paragraph an option to click here and it will take you to all the court documents which will answer all the questions members may have. The final settlement date is September 28, 2023 unless there is an appeal by a class member, in which case the appeal would have to be heard or dismissed prior to final approval. There is another status conference October 25, 2023 which Elaine will attend virtually through LACourtConnect. Much thanks to Elaine for monitoring and reporting to us on this.

### ACO REACH In my last column I reported that I

had sent CalPERS Board Members just prior to their July offsite my research into the most recently approved list of REACH ACOs in California documenting their shortcomings, lack of compliance with CMS requirements, and lack of responsiveness to some I had contacted by phone. I also asked in that report that they put ACO REACH as a topic for their next Pension and Health Benefits Committee (PHBC) meeting and consider asking President Biden to terminate the program. Since then, I have found more information regarding the dangers of Private Equity's (PE) widespread acquisition of healthcare in the US and California. This most recent infiltration of PE into Traditional Medicare by becoming ACOs is simply the continued expansion of what we all know has been occurring on a larger national scale for the last 10 years. A recently released report, Monetizing Medicine: Private Equity and **Competition in Physician Practiced** Markets, highlights PE's voracious acquisition of physicians' practices over the last several years. The lead author is Richard Scheffler, PhD of the UC Berkeley Petris Center on Health Care Markets and Consumer Welfare. I had the opportunity to see and hear directly from Dr. Scheffler when he served on the

Healthy California for All Commission. The report "provides convincing evidence that incentives to put profits before patients have grown stronger in PE owned physician practices", and that specialty providers' costs significantly increase after becoming bought and controlled by PE. I sent this additional information to the CalPERS Board in August, asking again that they discuss ACO REACH at their September PHBC meeting. In my August report I also announced my resignation as Chair and thanked the CalPERS Health Team and leadership for their work and accessibility to me personally. I did receive several nice emails from Board members wishing me well and thanking me for my advocacy for retirees. However, there was no commitment to discuss REACH at a Board meeting. There was some indication that Health Director Moulds would be asked by the Board to further research the concerns I and others have raised and report back to the Board. So the door remains slightly open. It remains mind boggling to us that with 100s of health advocacy groups and local governments and the California State Legislature soon to oppose REACH and the fact that PE companies make up a significant percent of the 132 ACOs, that CalPERS won't come out and oppose it to protect its affected retirees.

#### **Dental Benefits Update**

Unfortunately, there is not much new to report on our concerns regarding Delta Dental. As previously reported, we met with CalHR on February 28 and identified many problems with our Delta coverage and the hardships our members are facing since so many dentists throughout California are dropping Delta for their low reimbursement rates and in some cases lowering reimbursements. Also, there's been no increase in their maximum allowed annual cap of \$2000 which has been in place for 40 years. Delta essentially has a monopoly on our dental benefits, with the exception of the inferior pre-paid plans, since CalHR has granted them "evergreen status" meaning they don't go out to bid and allow competition when the contract expires. CalHR had told us they would meet again with us after digesting and sharing our concerns with Delta. 4 months passed and no meeting was scheduled. When we inquired about a meeting in June, we were told they would be reaching out to schedule soon. 2 more months have passed since then with no word.

We have received indication that Delta rates and benefits for 2024 will be the same as in 2023, so it appears any action they may take to address our concerns may not happen for another year, if then. That concludes my final report. The good work of our HBC will continue. It's been an honor serving CSR.

## Thank you for your service, Larry Woodson!

Our CSR Health Benefits Committee (HBC) chairperson, Mr. Larry Woodson, is stepping down after 8 years of important advocacy, research, and representation of our 43,000 members before the CalPERS Board and legislators. Mr. Woodson has decided it is time to pass the Health Benefits Committee Chair baton to his Vice Chair, Mr. Tom Considine. Over the years, Mr. Woodson has been instrumental in helping members with their challenges pertaining to accessing, understanding, and utilizing the CalPERS healthcare programs. His research has been extensive and thorough, providing us with reports on what, why, and how things are changing, so we can better understand our options. Mr. Woodson's outstanding work has advanced our mission to protect the pension and health benefits of all retired state employees.

Thank you, Mr. Woodson, for your representation, dedication, and years of service to the California State Retirees Health Benefits Committee and to our members.



#### Mediterranean Ravioli

#### Ingredients

2 (8 ounce) packages frozen or refrigerated spinach-and-ricotta ravioli

## CSR BILL WATCH

The State Legislature returned from its month-long summer recess on August 14, and so began the process of approving or rejecting hundreds of bills still alive in the first year of the 2023-24 session. The Legislature has until September 14 to act on legislation before they go home for the year. Governor Newsom must then review and sign or veto all the bills that make it to his desk no later than October 14. I am happy to report that the California Senior Legislature (CSL) will live on for the foreseeable future. On July 21, Governor Newsom signed AB 559 (Boerner), CSR supported legislation, which extends the sunset date for the California Senior Legislature Voluntary Tax Contribution Fund to remain on state income tax returns through 2030. The voluntary tax contribution helps to fund CSL and was set to expire in 2023. CSL is a volunteer organization that advocates for senior citizens and allows them to remain active and engaged in the legislative process. CSR has stepped up many times in recent years in support of legislation to keep the CSL voluntary tax contribution check off box on state tax returns. Obviously, there is much legislative work to be done. Here is an update on other bills that CSR supported this year and may be of interest to CSR members:

### Support

AB 46 (Ramos) Would exclude from state taxation the gross retirement income received by retired members of the U.S. Armed Forces and recipients of the Department of Defense's Survivor Benefits Program. AB 46 will honor those who have dedicated their lives to serving our country while helping to retain and attract uniformed service retirees.

#### STATUS: Awaiting hearing in Senate Appropriations Committee.

#### AB 559 (Boerner)

Would extend the sunset date for the California Senior Legislature Voluntary Tax Contribution Fund to remain on the state income tax return through 2030, to provide ongoing financial support to the California Senior Legislature.

#### STATUS: Signed by the Governor and Chaptered by the Secretary of State on July 21, 2023.

**AB 616 (Rodriguez)** Would enact the Medical Group Financial Transparency Act, which would authorize the disclosure of financial reports and financial statements of providers and physician organizations collected by the Office of Health Care Affordability and financial and other records of risk-bearing organizations be made available to the Department of Managed

#### Health Care.

## Savvy Senior: How to organize your records so your family won't have to

Dear Savvy Senior,

I would like to get my personal, legal and financial information organized so my kids will know what's going on when I'm no longer around. Can you offer any ideas on the best way to do this? – Procrastinating Paul

Dear Paul,

Organizing your important papers and getting your personal and financial affairs in order is a smart idea and wonderful gift to your loved ones. Here are some tips to get you started.

#### **GET ORGANIZED**

The first step in getting your affairs in order is to gather up all your important personal, financial and legal information so you can arrange it in a format that will benefit you now, and your loved ones later. Then you'll need to sit down and create various lists of important information and instructions of how you want certain things handled when you die or if you become incapacitated. Here's a checklist of areas you need to focus on.

#### PERSONAL INFORMATION

• Contacts: Make a master list of names and phone numbers of close friends, doctors, and professional advisers such as your lawyer, accountant, broker and insurance agent.

• Medical information: Include a list of medications you take, along with any allergies and illnesses.

• Personal documents: Include such items as your birth certificate, Social Security card, marriage license, military discharge papers, etc.

• Secured places: List all the places you keep under lock and key such as safe deposit boxes, safe combination, security alarms, etc.

• Digital assets: Make a list of all your digital assets, including everything from social media

#### LEGAL DOCUMENTS

Will, trust and estate plan: Include the original copy of your will and other estate planning documents you've made.
Financial power of attorney: This document names someone you trust to handle money matters if you're incapacitated.

• Pets: If you have a pet, give instructions for the care of the animal.

• End of life: Indicate your wishes for organ and tissue donation and write out your funeral instructions. If you've made pre-arrangements with a funeral home include a copy of agreement, their contact information and whether you've prepaid or not. • Advance health care directives: This includes a living will and medical power of attorney, which spell out your wishes regarding your end-of-life medical treatment when you can no longer make decisions for yourself. **FINANCIAL RECORDS** 

#### FINANCIAL RECORDS

• Financial accounts: Make a list of all your bank accounts, brokerage and mutual fund accounts, and any other financial assets you have.

• Debts and liabilities: Make a list of any loans, leases or debt you have – mortgages owed, car loans, student loans, medical bills, credit card debts. Also, make a list of all credit and charge cards, including the card

numbers and contact information. • Company benefits: List any retirement plans, pensions or health benefits from your current or former employer including the contact information of the benefits administrator.

• Insurance: List the insurance policies you have (life, long-term care, home, auto, Medicare, Medigap, prescription drug, etc.) including the policy numbers, agents, and phone numbers.

• Property: List real estate, vehicles and other properties you own, rent or lease and include documents such as deeds, titles, and loan or lease agreements.

• Taxes: Include the location of your tax records and your tax preparer's contact information. Keep all your organized information and files together in one convenient location, ideally in a fireproof filing cabinet or safe in your home. Also be sure to review and update it every year, and don't forget to tell your kids where they can find it.


