## CSR 2024 Election Results & Updates!

embers of California State Retirees in all chapters except 1, 8, 1V1 10 & 21 cast ballots to choose their representatives for chapter officer positions and for delegates at CSEA's General Council and CSR's Delegate Assembly. There were no contested races in Chapters 1, 8, 10 & 21 so no balloting material was sent out in these chapters. Each chapter is allotted one delegate for every 200 members or major fraction thereof. The delegate count per chapter is based on the number of chapter members in good stand-ing 120 days prior to Delegate Assembly. Listed on pages 2 and 8 are your newly elected chapter officers and delegates. \*Subject to any election protests. On May 21, ballots in the CSR Chapter Officer and Delegates Election were sorted and electronically counted by California Elections Company (CEC), the same union vendor CSR has used for previous chapter elections. The nomination period ended on February 28 and candidates then had until March 26 to submit a candidate statement. Ballots for contested races were mailed April 22 and the deadline to return ballots was May 20. The ballot count took several hours and once the final tallies were in, CSR members had officially voted on their new chapter officers and delegates. You can find election results on pages 2 and 8. ## **SAVVY SENIOR**

#### Savvy Senior: Long-Term Care Benefits for Veterans and Surviving Spouses

Dear Savvy Senior, I understand that the Veterans Administration has a benefit that can help veterans and spouses with long-term care costs. We recently had to move my elderly father into an assisted living memory care facility, and my mother will probably need care too in the near future. What can you tell me? Searching for Aid

#### Dear Searching,

The Veterans Administration (VA) does indeed have an underutilized benefit that can help wartime veterans and their surviving spouses pay for a variety of longterm care costs.

This benefit, called "Aid and Attendance," is a special pension that's paid on top of existing VA pensions for eligible veterans and surviving spouses. In 2024, it pays a maximum of \$2,727 a month to married veterans: \$2,300 a month to single veterans; or \$1,478 a month to a surviving spouse. The money is tax free, and can be used to pay for assisted living, memory care, nursing home or in-home care services. Currently, around 156,000 veterans and survivors are receiving the Aid and Attendance benefit, but many thousands more are eligible who either don't know about it or don't think they qualify.

#### **Eligibility Requirements**

To qualify, your dad must have served at least 90 days of active

military service with at least one day of service during a period of war, and not have been discharged dishonorably. Single surviving spouses of wartime vets are eligible if their marriage ended due to death. In addition, your dad will also have to meet certain thresholds for medical and financial need to be eligible.

To qualify medically he must be either disabled, or over the age of 65 and need help performing basic everyday living tasks such as eating, bathing, dressing or going to the bathroom. Being blind or in a nursing home due to disability or receiving Social Security Disability or SSI also qualifies him. Single surviving spouses have no age restrictions, but they must require help with basic everyday living tasks to be eligible.

To qualify financially your parents

you'll need to fill out VA Form 21-2680 and mail it to the Pension Management Center (PMC) for your dad's state. You'll need to have your dad's doctor fill out the examination information section. Or you can also apply in person at a VA regional office near your parents. For more information or to download application forms see VA.gov/pension/aid-attendancehousebound. You can also call the VA at 800-827-1000 if you have questions. If you need some help, you can appoint a Veteran Service Officer (VSO), a VAaccredited attorney or claims agent to represent your dad. See VA.gov/ ogc/apps/accreditation/index.asp to locate someone. If your dad is eligible, it can take months for his application to be processed, so be patient. You should also know that if your dad's Aid and Attendance application is approved, the VA will send a lump sum retroactive payment covering the time from the day you filed the application until the day it was approved. Then your dad receives monthly payments going forward.

## **TO YOUR HEALTH**

Below are updates on 1) Delta Dental, 2) the Blue Shield/ Providence Contract, 3) the UC/Anthem Contract, 4) Optum Rx Mail Order and addresses a member's concern under "Ask HBC."

#### **Delta Dental:**

CSR staff and I have remained committed to work with CalHR to determine how and where improvements can be made to the dental benefits for retired members. As a result of our interactions with CalHR, we received a letter from their Director providing an update of their conversations with Delta Dental. In the letter, Director Eraina Ortega pointed out "In California, approximately 78% of all licensed dentists are contracted with Delta Dental PPO & Dental Premier networks of which 60% participate in the Delta Dental PPO network." Director Ortega also pointed out, "The State currently has 94% of its members utilizing a contracted dentist under the Delta Dental plans." I did not include the entire text of the letter received from Director Ortega, but I want members to have the opportunity to read it. As previously reported, I worked with CSR staff to develop a survey, which was sent to all CSR members with a current email on file. This was done to give members an opportunity to convey their experiences with Delta Dental

and for us to see, with actual data, the scope of the problem with Delta Dental. Although we get a lot of complaints through email and phone calls.

Your input to the survey is important and beneficial. CSR will continue to stay engaged with CalHR and work to find solutions and/or options to benefit our members. Lastly, if you are still wondering if you were impacted by the Delta Dental data breach and have not been contacted by Delta Dental, you can call them at (888) 899-3734 and ask them to verify if you were impacted.

## Blue Shield/Providence Contract:

On April 15, 2024, CalPERS notified Stakeholders via email that "the contract between Blue Shield and Providence St. Joseph Health System is set to expire on May 31, 2024 and although negotiations are continuing, health plans are obliged to notify members of the potential termination." This matter only affected Basic plan members. I contacted CalPERS to get an update on the contract negotiations and was informed they were successful and a new contract was signed. Great news for our Blue Shield Basic plan members who seek treatment through the Providence system.

#### **UC/Anthem Contract Update:**

Anthem Blue Cross and UC Health have continued to work on the new contract language for 2024, which would allow members enrolled in PERS Platinum, PERS Gold, Anthem Blue Cross Traditional HMO and/or Anthem Blue Cross Select HMO to continue accessing care through the UC Health system.

As reported last month, this agreement and the contract only affects members in the Basic plans. This does not impact members in Medicare plans.

I contacted CalPERS to get an update on the contract negotiations and was informed they were

successful and a new contract was signed. Great news for our Anthem Basic plan members who seek treatment through the UC system.

#### **Optum Rx Mail Order Update:**

As reported last month, we are getting a lot of complaints from members regarding the new method by which members must refill their maintenance drug prescriptions through Optum Rx. Beginning in January 2024, in order to receive a 90-day supply of some medications, members have to order their prescriptions through the Optum Rx mail order service. A benefit of ordering through Optum Rx is members get a 90-day supply at the price of a 60-day supply.

For those members who choose to use their local pharmacies, they are only allowed to order a 30-day supply and will not enjoy the extra cost savings. One member complained he was on a medication which could not be refilled until the 90 th day passed, then he would have to wait for delivery, leaving him without his medication for several days.

I called CalPERS to see how they are dealing with this type of situation, but as of this update, have not heard back. If you are experiencing delays in getting your prescription medication, you are encouraged to call the CalPERS Customer Service number at (888) 225-7377.

#### **Ask HBC:**

Last month I reported on a member who was having problems getting his medical supplies from a Kaiser program called "Medline." According to the member, Medline, which is known as a manufacturer and supplier of medical supplies, changed warehouses and his orders were not shipping promptly. Even though the member called Medline to check on the status of his order, he was told it was "still pending" ten days after he submitted the

order.

I made contact with CalPERS to have them look into this matter and received this reply: "The rollout of this new warehouse and distribution route did cause some delays in their supply chain, as you are aware. Medline has been doing everything they can to get this fixed, including working on weekends. They estimate that all shipping is expected to be back to normal by May 5th.

Kaiser and Medline offered their sincere apologies for inconvenience the recent shipping delays caused the CalPERS members. Please let us know if you have any questions." The member has since reported he received his order a few days after he reached out to me. If any members are experiencing problems with Medline or any other CalPERS related program, they are encouraged to call CalPERS Customer Service at



#### Spicy Peach-Glazed Grilled Chicken

#### **Ingredients**

1/2 cup peach preserves

3 tablespoons finely chopped/seeded jalapeno pepper

1 tablespoon reduced-sodium soy sauce

1-1/2 teaspoons chili garlic sauce

1 teaspoon spicy brown mustard

1 teaspoon olive oil

1/8 teaspoon plus 1/2 teaspoon salt, divided

4 boneless skinless chicken breast halves (6 ounces each)

#### **Directions**

In a small bowl, combine the first six ingredients; stir in 1/8 teaspoon salt. Reserve half of the glaze for serving. Sprinkle chicken with remaining salt; place on greased grill rack. Grill, covered, over medium heat 5 minutes. Turn; grill until a thermometer reads 165°, 7-9 minutes longer, brushing tops occasionally with remaining glaze. Serve with reserved glaze.

## CSR 2024-25 State Budget – May Revise Report

n May 10, Governor Newsom released his May Budget Revision and made official what had long been expected -California's state budget deficit has grown to \$45 billion, up from \$38 billion in January. Since January, tax revenue collections have fallen an additional \$7 billion behind the modest projections made in the Administration's initial budget proposal. After accounting for the \$17 billion in early action budget cuts approved in April, the Administration and Legislature now must come to agreement on an additional \$28 billion in cuts, shifts, deferrals, transfers, borrowing, and reserve spending to produce a balanced budget by the June 15, 2024, deadline We are happy to report that the Administration's proposed cuts, deferrals, transfers, and other budget adjustments do not threaten CalPERS pensions, or the retiree health care benefits state retirees depend upon. Instead, the Administration's balanced budget continues to rely on billions in cuts to programs funding climate change remediation, housing, university and school facility construction, and middle-class scholarships. Billions more in previously authorized spending for transit and intercity rail, preschool, transitional and full kindergarten facilities, clean energy investments, and homeless and housing programs will be delayed this year and for years to come. In the fiscal year, billions of dollars in other general fund spending will be shifted to special funds and bonds. State employees will also feel the impact of the cuts. As they did in January, the Administration's budget continues to rely on \$1.5 billion in savings created by eliminating an

estimated 10,000 vacant positions. The May Revise proposes to make vacancy sweeps - and the savings accompanying them – a permanent practice. The revised budget also makes a new proposal to institute a 7.95% across the board cut to all state department government operations in the new fiscal year to save \$2.2 billion. The position sweeps and across the board cuts will no doubt make life more difficult for state employees as they try to deliver services to Californians with fewer people and less resources.

In a shift from the January proposed budget, the May Revise proposes to access \$13 billion in Rainy Day Fund reserves but spreads the money over two budget years (2024-25 and 2025-26). This will leave over \$19 billion available for use to address future budget deficits that have been predicted by the Administration and the independent Legislative Analyst's Office. In the end, as proposed the 2024-25 state budget will total \$288 billion, with \$201 billion in general fund expenditures. This is significantly lower than the state's current budget of \$311 billion.

Here are a number of other items of interest to CSR members that largely remain intact as proposed in January:

#### **CalPERS Contribution**

The proposed budget includes \$6.9 billion for the statutorily required annual state contribution to CalPERS for state pension costs. This is \$1.6 billion lower than the 2023 Budget Act due to the application of prior Proposition 2 debt repayment funding paid to CalPERS.

### **Supplemental Contribution to CalPERS**

The Governor maintained his commitment to the security of state retiree benefits by including \$420 million in one-time Proposition 2 debt funds as a supplemental payment toward the state plans' unfunded liabilities. This is a reduction from January of about \$400 million made necessary by declining revenues.

#### **CalPERS Health Care**

The proposed budget includes \$7.2 billion to meet the state's health care and dental obligations to active and retired state employees. Of the proposed money, \$2.8 billion covers the health and dental benefit costs for retired state employees.

#### **Prefunding Retiree Health Care**

The proposed budget continues the state's commitment to jointly prefund (with active employees) retiree health care benefits for future state retirees. The budget includes \$683 million, including \$375 million in one-time Proposition 2 funding in 2024-25, for the employer's share of contributions to pay for future retiree health benefits. Employees will make the same contribution, collectively, out of their paychecks. Current retiree health care benefit funding is expected to remain as an annual pay-as-you-go state budget item until 2045, when the collectively bargained retiree health care trusts managed by CalPERS are expected to take over payment of the benefits.

## State Employee Pay/Budge Savings

With updated cost estimates, the May revise reduces the State Employee compensation

line item to \$1.2 billion (down \$100,000 from January). This is the money that will pay for collectively bargained pay increases, higher health care costs for active state employees, and retiree health care prefunding contributions for active employees. As usual, the proposed budget does not include any money for collective bargaining agreements that have yet to be reached. That money will come later and be funded by budget trailer legislation after agreements are completed. Fortunately, the proposed budget does not propose furloughs, personal leave days, or any other similar reductions in active state employee salaries.




